

Chairs report for the virtual Business Meeting being held on the 22nd August '22.

In the last month I have attended the following meetings and business on behalf of QDCC.

FBWH Aug virtual infrastructure meeting

I attended the quarterly meeting of the FBWHMC and reported that an Infrastructure meeting was held with NQCC, stakeholder groups Fife & Edinburgh Councils, Transport Scotland, HES and FBWHMC members. My thanks to Miles Oglethorpe for organising the meeting and the comprehensive notes taken. The notes set out the agenda for future meetings and will be an important benchmark for the next five years plan that is lodged with UNESCO. This was a very important meeting for the communities on both sides of the river as it seeks commitment from all of the stakeholders to work towards improving the quality of life first for residents and visitors. It's not sustainable doing nothing about improving the infrastructures of the towns which has been the case for the last six plus years

The next steps are the appointment of World Heritage Coordinator. In the interim there's a commitment to hold a further meeting in the autumn.

Hawes Toilets improvements included in the UK Growth Fund Application

QDCC has been complaining about the condition of the toilets for many years! They have been included in the funding list for Edinburgh's UK Shared Growth Fund. We were advised of the CEC's intention to seek funding by Gareth Barwell, Head of Place when visiting Queensferry at my invitation to discuss and see first-hand some of the Town's infrastructure issues.

Museum Services

I have been in contact with Karl Chapman Culture and Venues Manager about museum services and opening of Queensferry Museum. He will revert to QDCC after officers are clear of the Edinburgh Festival.

<u>Liner Visits</u>

We are well into the programme of visits, two liners visited in August and it just happened to be on Ferry Fair Week which is far from ideal. However Queensferry just about coped. A positive is the trial of the call down of buses to the Hawes, as there's no capacity for parking due to the showground occupying the car park. I have requested a close out meeting with Council Officers. An agreement that QDCC had with CEC not to land liner passengers at Queensferry during Ferry Fair week was reneged on.

22' Ferry Fair

Congratulations to the Fair committee for organising a very successful Ferry Fair weeks' programme of events which was well attended. No doubt the weather helped as it was exceptional.

High St Improvements

First Phase was completed in May. Some snagging work is yet to be completed. A paper on potential locations for parking has been compiled but QDCC is yet to meet with CEC Officers to discuss the papers content. We will learn about the Sustrans bid for next phases of the High St in September.

Meeting with Cala Representatives – Cala Pledge

Along with the Vice Chair/Secretary and Treasurer I met with Cala representatives Alison Cunningham and Amy Pankhurst to discuss and learn about Cala's Community Pledge intentions. The proposal is to deliver a series of commitments to Queensferry. To ensure that the pledge is tailored to suit local needs then Cala is keen to involve QDCC.

Discussions around the pledge are in the early stages of forming and shaping the pledge. We will be reaching out to involve QDCC Convenors accordingly.

EACC Meetings

I have attended two meetings of the EACC primarily to discuss the diary for EACC meetings and attendees going forward until the end of the year. The notes and information can be found on the EACC Website; <u>http://www.edinburghcommunitycouncils.org.uk/</u>

Schools review – SQUIDS after School's Club

I was invited by SQUIDs after school club and Rosebery Hall M.C.to attend a meeting with Robbie Crockatt, CEC School Estate Planning Manager and Julie Duncan Property Services to discuss the future provision of buildings for delivering after school clubs. The present building used behind QPS is an old temporary school building from the late '60's which forms an important part of the Community Centre, is in poor condition and at "end of life". CEC gave a commitment to consider the needs of the community within the primary school's review but emphasised that SQUIDs and QDCC should table a paper at the time of the consultation.

Queensferry Artwork - Hawes Seal and Guardian of the Bridges

The Environmental Convenor and I have been trying to secure funding with little success from late last year to repair both pieces of Artwork. The artwork is not listed with CEC and therefore doesn't qualify for funding.

The Seal has concrete stress corrosion around the eye. I have obtained a quote from Garcia Ainsworth, a contractor recommended by CEC and the basic repair will cost towards £1500. I remain optimistic that we can secure funding for the Seal and have yet to have a discussion with a potential sponsor.

The mosaic tile pieces are breaking free from the structure on the two humps of the Guardian. It is in need of urgent repair. The interpretation plaque is missing. We have corresponded with the artist Debbie Ryan and an indicative cost for a lasting repair is up to £4000. I doubt we will be successful in raising funds for its repair. A solution suggested is to remove the structure however this would be a costly piece of work too. And there would be grounds reinstatement costs as well. Neil and I are looking at a diy repair for the Guardian.

Secretary's Report A Terry Airlie

CORRESPONDENCE SECRETARY – AUGUST REPORT

1. The QDCC mailbox – both incoming and outgoing has once again been a bit quieter this month, no doubt continuing as part of the general holiday period.

Once again there are a number of recurring items namely the High Street refurbishment project, and the South Scotstoun, Springfield(Queensferry Heights), FerryMuir Gait and Builyeon Road housing developments.

A couple of further representations from residents from both Echline and Longcrook were received relating to excessive dust from the Builyeon Road development but this does seem to have died down somewhat since last month.

Further representations were received relating to the ongoing Virgin Media works and the continuing disruption. Along with other Community Councilors I have written to VM both in a personal capacity as well as on behalf of QDCC. As before VM communications leave a lot to be desired with a number of mails unanswered.

It appears that a number of previously completed areas require remediation due to shoddy workmanship. No dates for these are available at the time of writing.

I had written to our Ward Councillors on this matter and await feedback.

Residents continue to engage with QDCC via social media although I still continue to receive quite a few phone calls – mostly from people who believe that QDCC is "The Local Council" and responsible for many of the services normally delivered by CEC. Wherever possible I try to pass on these queries to the relevant local authority departments/officials

Since the last meeting I have fielded a number of calls from residents with queries relating to availability of social housing and a request for assistance with a house move, a request to provide or assist with Justice of the Peace services, the ongoing binmen strike, a call from an angry resident who was trying to get home from Edinburgh but buses were too full to allow passengers to board, and a contact relating to a fall in the High Street on BurryMan day – details of which have been forwarded to CEC

I continue to engage with CEC Officers on behalf of QDCC and should any further relevant information be received I will continue to share with everyone as necessary. A request for information from EACC was also processed My thanks go out once more to Diane for continuing to work on what seems to be a never ending number of planning matters on behalf of QDCC, Liz for taking and generating meeting minutes and to Graeme for organizing both online meetings and the administration of our website and social media presence.

- 2. A number of website enquiries have again been received since the last meeting on various topics, and these have been circulated to respective stakeholders and dealt with accordingly both by myself and fellow Community Councillors
- 3. Along with long with the Chair and Treasurer I met with Cala representatives Alison Cunningham and Amy Pankhurst to discuss and learn about Cala's Community Pledge intentions.
- 4. On behalf of QDCC I continue to correspond with CEC officials, CEC Councillors, and local residents on various community related matters. I continue to distribute information to office-bearers, members and/or portfolio conveners as appropriate. Can I please remind all members to include me in the circulation of any email chains involving any QDCC related activity

Community Engagement

QDCC continues to communicate with residents, authorities, stakeholders, developers and internally using various online tools: social media (Facebook, Twitter, Instagram), QDCC website, email, messenger, MS Teams and Zoom; the monthly meetings via MS Teams are open to the public by request via our website, advertised on our website and social media channels. Subjects discussed through those channels are incorporated in to each relevant sub-committee's reports. Anyone wishing to contact the community council on any matters please do so through our website <u>http://www.queensferrycommunitycouncil.co.uk/</u>, where all communication channels are explained.

Spotlight Magazine

Distribution will alternate monthly with online publication then print distribution; fresh content will remain bi-monthly. Distribution will now mainly be through key static dispensers in the area.

Cruise liners

A trial of a just in time collection/drop off excursion coach system was conducted w/c 7th Aug for two liner visits. This was through necessity rather than proper trial, due to the booking of two liners in the Ferry Fair week, despite previous agreements. The system trialed by CEC was cautious with a complete closure of Bankhead Rd to all traffic other than excursion coaches. Consequently, Lothian Buses diverted the 43 service away from servicing a significant part of Queensferry in addition to Dalmeny. The situation was exacerbated by the scheduled closure of Milton Farm Rd. Although this work was postponed, the Road Closed signage was still implemented.

QDCC will have a debrief with council officials and Lothian Buses.

Key points to discuss for future :

- Alternatives to complete closure of Bankhead Rd e.g. maintain Lothian Buses' access.
- Improve prior communication to excursion coach drivers on stacking and swift departure from load/drop off area (many excursion coach drivers knew nothing of the system)
- Ships' tender coordination with coaches (significant difference in effectiveness between operators on the two trial days)
- Coordination of other TTRO's.
- X99 stacking on Bankhead Rd (no reason this can't be implemented)
- Complete Ferry Fair week ban on liner visits
- Accommodation of growing Independent coaches

It should be noted that the majority of problems relating to liner visits remains not so much with the ships or their passengers but the excursion coach operators who account for a significant but diminishing percentage of the landing passengers. The continued use of the car park has been the bone of contention for many years. This displaces usual local trade

which is just nowhere near compensated for by any trade from the landing passengers for many local businesses.

Also note that the 'trial' delivered no benefit whatsoever to the town as the Hawes Car Park it aims to free up, bringing back local trade, was occupied by the fairground. This was a necessary operation which allowed test of the logistics, rather than a proper costs/benefits trial. All points will be discussed and negotiated with the various stakeholders.

QHS Community Facilities

The QHS swimming pool summer holiday schedule was proven financially viable in the weeks prior to the closure due to a shortage of CO2 within CEC's supply chain. This supports the case for continuation next summer. Shorter school holidays are more complex, recruiting seasonal staff for 6 weeks in summer is achievable and viable, however for just one or two weeks outwith summer, not so simple. QDCC and EL will continue to look for any opportunities.

The newly negotiated **increased QHS term time pool schedule** is now in place. This gives significantly more hours to community access outside school hours whilst maintaining the community support and financial contribution of swim clubs and lessons for all ages and abilities. The schedule (subject to adjustments for demand) can be viewed <u>on our website</u> <u>here</u>. EL are still playing catch up with the app and website timetables to reflect that schedule; swim session booking is no longer necessary other than Family and Junior sessions.

Edinburgh Leisure have introduced an additional membership tier for young adults 18-24 yrs at £25 per month for access to all EL gyms, pools, fitness classes & the climbing arena. We already have the Full Junior membership for under 16's with same city-wide access plus golf courses for £10.50 per month. Combined with free bus travel for under 22's, this offers a huge range of activities for young people over the summer for very low cost. Adults' Queensferry Membership at £28 per month which gives access to gym, pool, sauna, steam room and fitness classes, offering significantly better value than the Pay as You Go options. T&C's apply, see website for details - <u>Edinburgh Leisure</u>

Young People Engagement

The Summer Fun Programme, an initiative from Lifelong Learning Services (CEC), supported by local organisations such as QDCC, Edinburgh Leisure, Port Edgar Watersports CIC, Maid of The Forth, HoneyPot Creative Café, GreenFerry (Hawthorn Bank Garden), and funded with the help of the Almond Neighbourhood Network and Edinburgh Food Project, was successfully run for three weeks over the summer holidays.

A more detailed report from Anne Marie Boyd, Youth Worker Organiser....

Since my last update two weeks in to the programme, the third and final week of the summer youth programme was very well attended. On offer during the week there was Paddleboarding, kayaking, Wellbeing Wednesday with trampolining, Reconnector club, Park life and picnics in the park. Over the course of the final week 191 spaces were taken up. The

three-week programme altogether provided 510 different sessions. A rough calculation shows that 353 unique young people benefitted, and some returning for further sessions.

We sent out feedback requests for parents and young people to fill in and here are a few of the comments:

inclusion, local accessibility to go along with friends, free to all and variety of activities This group has been great for (name hidden) and she's enjoyed it so much and met lots of new friends through this. Everyone involved has been great - thank you so much. It's been a wonderful programme and really helped fill time in the holidays with exciting things to do This was a fantastic resource. QDCC – Environmental Committee Report for August 2022

Council Waste Ground on Burgess Road

I have chased CEC in relation of the site being made secure and all fly tipping removed and the overgrown trees and shrubs dealt with.

Dangerous Wooden Steps near Dalmeny Oil Tank Depot

Chaser send to CEC to enquire what progress is being made with regard to the dialogue they have entered into with the land owner on which the steps are located to remind them of their legal responsibilities in relation to the step repairs.

Land opposite the High School

McKenzie Construction acknowledge the re seeding of the areas of ground adjoining the High School have proved unsuccessful which is primarily put down to the extended period of dry weather.

They plan to review matters again at the end of this month to decide what follow up action is required. I shall continue to monitor the situation.

Plastic Free Queensferry

Plastic Free Queensferry will be holding an event in Queensferry Parish Church hall on the 10th September where various stallholders will be selling plastic free alternative products. Prior to this, in conjunction with the CleanFerry group a "litter blitz "will take place on a designated area in the town.

Community Sculptures in need of repair

The "Guardian of the Seas" sculpture is showing further signs of deterioration with the top side of one of the "humps" now exhibiting a large cavity exposing the internal steel structure , probably due to a combination of children sitting on it for photos and we suspect some vandalism too. Keith Giblett and I intend to undertake some immediate running repairs and then reach out to the wider community seeking support in terms of a financial contribution and/or technical expertise to deliver a more permanent and durable repair.

The minimum cost of work to repair the Seals sculpture will be circa £1,500. We intend to seek additional funding from contractors based locally to meet these costs as our current committed funding from benefactors is well short of this sum.

Other Community Matters

"Leaning Wall" -Dalmeny Estate perimeter near the Leuchold Gate entrance

I had the opportunity to have a brief discussion with one of the Rosebery Estate team who confirmed a structural engineers survey had been undertaken by CEC on the section of "leaning wall" near the Leuchold Gate entrance that is causing some concern. The matter of the responsibility for any necessary repairs to the wall is currently under discussion between the estate and CEC. The Rosebery Estate team member has committed to keep us posted.

Derelict vehicles at the entrance to the Dalmeny Estate next to Longcraig pier

I enquired at the same time what was happening with the 6/7 vehicles that sit next to the tenanted property at the Longcraig pier entrance to the estate. The vehicles appear to be "non-runners" and have sat there in a derelict state for many years and are detrimental to the ambience of the area. I was informed the estate are speaking with the tenants about this situation. As with the wall situation I will monitor progress.

Community orchard

Funding applications are being prepared by the Greenferry Planting Group to cover the cost of the purchase of trees and associated materials to create a community orchard on the site next to the Hawthorn Bank Community gardens. We hope this project will involve local primary and secondary school pupils as well as other community groups like the Rotary Club Environmental team. The anticipated timing of planting would be around October/ November 2022.

Rotary Environmental Team

The team filled 31 large sacks of weeds and the odd shrub from the perimeter of the Dalmeny Station car park on Sunday the 14th August. Clearly the car park perimeter has not been weeded for many years. This Sunday the 21st August the team will weed the smaller top half of the car park.

The sacks will be uplifted by the CEC task force team although there may be a delay due to current strike action.

Ukraine drop-in sessions on a Friday have been successful but as the issues have been resolved for individual groups including north Queensferry such as clothing, toiletries and teaching the numbers have fallen. Plan is to do another couple of weeks then wrap up but be responsive to individual situations as they arise. I am happy to be contacted directly.

As far as I am aware there is only 1 family in the area still waiting to be allocated a family. Others are in the process.

Foodbank is noting a rise in referrals. With the knowledge that things will become increasingly difficult for everyone would it be within the remit of this group to organize a day where people could drop in for advice and leave information for those who cannot make it? Envisage linking with the council housing officer and your homes/rights as well as local organisations, churches and the library. All input welcomed.

Ferry Elves we have already been asked by a couple of families if this will happen this year. As demand for this has grown, this year probably needs more of a team approach whilst maintaining confidentiality. We are unlikely to be able to have the storage of last year as other groups are back using the halls.

Transport Report for August 2022

- 1. Various Road and Pavement Closures Quite a busy month for TTROs relating to road restrictions or closure patterns over short periods of time, leading to calls for improved coordination. However the disruption can crop up for a multitude of reasons such as repairs, inspections, nearby utilities and events such as liner visits, street parties or Ferry Fair that won't naturally fit together even if schedules could be accurately predicted. There are usually alternative routes available and diversions advertised to public transport. The ongoing experience with Virgin Media occupying pavements and green spaces for long periods is a similar situation but represents a general eyesore across the town with questionable standards of reinstatement. It seems familiar across most communities and difficult to see what more can be done at QDCC to ensure such installations are better coordinated.
- Active Travel Consultation and Drop-In Session Initial feedback suggests around 50 members of the public provided responses at the drop-in event. The overall report from Atkins was being prepared earlier this month with an expectation of initial review by their client (CEC) followed by wider distribution.
- 3. High Street Resurfacing No recent updates from CEC and Ironside Farrar on June's submission to Sustrans. Keith requested another update meeting with the working group to review improvements carried out to date along with future plans, which are largely dependent on the funding profile. Difficulties with anti-social parking around the very substantial bollards at the Bellstane and a few other locations have already been fed back in the hope of attention by enforcement staff. Following requests to CEC, the entrance to Viewforth Bank industrial units now has Keep Clear advice written on the road, and yellow boxes were recently painted around the Priory & police station junction. Hopefully this will help avoid the risk of gridlock where the traffic lights become blocked by queuing traffic.
- 4. Public Transport The trend of short notice disruption to the published train service is likely to continue for a while, which is largely due to staff shortage and industrial relations matters. On days when only signalling staff are on strike it is now possible to run shuttle trains between Waverley and Inverkeithing, which can help some passengers. Although our own area has been spared bus industrial action, difficulties with resources and network stability continue at Lothian Buses despite emergency changes in July. Further schedule revisions to their commercial routes are due in September but these do not affect Queensferry and they have no plans for changes here in 2022. Driver shortage at First led to concern that they would terminate their contract with CEC to run some supported bus services at the end of August, including the 63. Further negotiation between council officers and operators led to a proposal where First could reliably deliver a reduced 63 timetable (every 90 minutes, 7am-7pm,

7 days per week) along the same route for up to 12 months if necessary. Clearly not ideal but perhaps a reasonable compromise given present operating challenges. The suggestion is financially beneficial to CEC in the short term and was due for consideration by their Transport & Environment Committee on 18 August. Unfortunately the committee meeting was adjourned through secondary industrial action taken by councillors, adding another layer of confusion for travellers trying to establish facts on the service to expect from next week. Another T & E meeting is scheduled for 1 September and although some motions and amendments could be debated along with the officer's report it seems almost certain that the 63 bus service will run to First's revised proposal from the end of August.

Update on no63 bus service

Following our petition last month, backed by over 1000 local people, and the scale of the community response, we're delighted to say that a level of the service will continue after the end of the month. It will be on a reduced timetable and frequency which is of course not idea, but it's significantly better than the full withdrawal of the service we were facing. The bus will run every 90mins as a daytime service (ie until around 6pm). First Bus are hoping that once driver shortages improve they can return to the previous service.

Transport & Environment Committee – postponed

The scheduled meeting of this committee was postponed at the last minute, when the meeting was due to start. The reason given was in support of the staff who were striking. However we felt that after such a long gap since the last meeting, and the urgent issues needing addressed, the meeting should have gone ahead. We voted against postponement, but it was pushed through by other political groups.

Council strike - waste services

As of the time writing this update, the strike action continues in Edinburgh. However a 5% payrise offer has been made by COSLA and we await a decision from the Unions on whether this will be accepted and end the strike. We ask residents to do what they can

to store their waste safely until the service resumes. There are recycling facilities in nearby Broxburn although they are due to start their strike in the coming days.

Hopetoun Road / Rose Lane

Following our update last month, the new box junction has been installed at the junction of Hopetoun Road and Rose Lane. We've had feedback already to advise that it's made a huge difference to those who were being affected by the back up of waiting traffic.

Builyeon Road detailed plan published

The first detailed plans for the major new housing development at Builyeon Road have been published. Whilst we objected to the original plan to allow house building on this site, now that it is progressing our concern is to ensure the best scheme for the town. The new detailed plans for the south and west of the site would build 184 new flats and 214 new houses with a mix of 2-5 bed homes. We continue to have deep concerns about the proposed realignment and reconfiguration of Builyeon Road through the new housing site. This will fundamentally change the access in and out of Queensferry and shows why it is so important to reopen the direct access to the A90 from Ferrymuir.

Garden waste - registration open until 6 September

The main registration period for garden waste collections for Nov 2022-Nov 2023 is now open. Registration is open until 2pm on 6 September. The cost for the full year is £35. Residents can now choose to pay by direct debit and will then be automatically renewed each year. Exemptions continue to be available.

Bo'ness Road Crossing

We had previously reported that the long-awaited pedestrian crossing on Bo'ness Road near Echline Primary was due to be installed in July. Unfortunately, a national shortage of the electrical equipment required for a crossing of this kind has held up installation. However, we are hoping the materials will be available for the crossing to be put in place over the next couple of months.

Cllr Work

Cllr Norman Work's report for August 2022 meeting

Ferry Fair: Another fantastic Ferry Fair helped by having glorious weather all week. Attended a few events including being part of a winning quiz team. Well done to everyone for making it a brilliant event. Also well done to Andrew Taylor and the Burryman Team for keeping a brilliant tradition alive.

Pedestrian Access: I've been contacted by several residents in the new Hawthorn Garden Development concerned that there is still only the one access for pedestrians and that there is a grass verge on the B800 where a pavement should be. I contacted Taylor Wimpey to ask about the grass verge and when the access to Scotstoun Avenue is expected to be open. According to Sarah Paton-Butler from Taylor Wimpey, there is a path at the grass verge due to be added to the B800 exit which will join other paths and that should happen shorty. Taylor Wimpey has amendments to make to the existing cycle path out of the estate and they haven't managed to finalise matters with the local authority in relation to the path. There will also be a path at the other end of the development, eventually which will allow residents to exit towards Dalmeny station which should prove useful also.

63 Bus Service: The contracts were awarded for an initial 2-year period commencing Summer 2020 with 2 further 12-month options to extend. Previously it was reported that First Bus were not minded accepting the contract extensions due to lack of driver resource. This may have meant that services could have ceased to operate at contract end date of 30 August 2022. There was significant concern that this date would not allow sufficient time to procure alternative provision. Discussions have been ongoing, and officers met with First Bus representatives again on 29 July to investigate any possibility of continuing services beyond 30 August.

First Bus has now agreed that they will be able to continue at least some level of service beyond the 30 August. First Bus are working extremely hard on driver recruitment and are hopeful that the current situation will improve over the coming months.

I've attached proposed changes to the 63 tendered service operated by First Bus. I can understand that there the frequency is being reduced but the later buses should be kept and this is something I've put over to the officials in the council.

Strike action 18th - 30th August: <u>www.edinburgh.gov.uk/binstrike</u> information on the Council website about the Strike which gives a clear picture of what is happening and exactly which services are suspended.

This isn't an agreement between Edinburgh Council and the Unions representing workers in Edinburgh as all pay settlements are done through COSLA so must be agreed at a national level. The Scottish Government put £140m on the table to help local authorities meet the pay increases and the SNP representatives on COSLA voted for a 5% pay uplift which might have avoided strike

action, but unfortunately, SNP were outvoted by Labour, Tories and Lib Dems who voted for only a 3.5% pay uplift for workers.
