I was invited to join a group of youths from Queensferry Youth Club who attended at Lar Housing Port Edgar to be given a safety talk and lay a brick and a tour of the site. The visit was well received and I was impressed with the questions and interest being shown by our young people in this historical site.

I also attended the QBG Business meeting (27<sup>th</sup> Aug) held in the Orocco Pier focussed on the High Street Improvements Project to learn about how CEC might support the local business during the works.

Along with Terry we attended the six monthly INEOS meeting (28<sup>th</sup> Aug) to be given an update on the business. The refinery site at Grangemouth is now closed and being decommissioned. At the end of the meeting we were given a tour around Hounds Point which was very informative.

I also attended the Builyeon Rd Primary School drop in session held in Echline Primary School, which is worthy of further debate by QDCC.

I continue to support the Secretary and Treasurer and Convenors with the day to day enquiries that are received both by email, verbally as well as replying to the ever increasing mailbox communications.

 QDCC mailbox activity has remained steady since the last meeting of the Community Council. I continue to respond as best I can in a timely manner My.thanks to Graeme for covering the mailbox whilst I was on holiday

Several telephone calls and website queries have also been dealt with and again my thanks go out to fellow Community Councilors who assist with the varied questions that I circulate requesting help to formulate relevant replies.

 Dialogue with CEC Officers to discuss the outcome of the Assets Review (renamed Queensferry Living Well) continues. We await the outcome of the consultation and the next steps.

- Dialogue continues with Ironside Farrar on the formulation of a Local Place Plan for Queensferry. An initial draft plan has been received and has been circulated to all Community Councillors for comment.
- We await details of the next stage of the Queensferry Connections Consultation from CEC. Comments received and concerns have been raised on proposals for Scotstoun Avenue following the initial session held on 3<sup>rd</sup> September

Residents continue to engage with QDCC – mostly via social media although I continue to receive some calls – mostly from people who believe that QDCC is "The Local Council" and responsible for many of the services normally delivered by CEC. Wherever possible I pass on these queries to the relevant local authority departments/officials.

Since the last full Community Council meeting we have fielded a number of calls and responded to several online queries from residents including further concerns relating to anti-social driving activity across Burgh. Other contacts relate to the condition of the Town Cryer building, the memorial benches located on The High Street, a report of a wasp byke adjacent to Queensferry High School, concerns associated with the TRO on Station Road, a request for support relating to a newly arrived family in town, a query re parking on Echline Avenue and Bo'ness Road and double yellow lines and a further complaint associated with unpleasant smells noted in the Springfield/A904/Queensferry Crossing area.

My thanks as always go out to Diane for continuing to deal with what seems to be a neverending number of planning matters on behalf of QDCC, to Liz for recording and generating meeting minutes and to Graeme for the administration of our website and social media presence.

2. I continue to correspond with CEC officials, CEC Councillors, and residents on various community related matters. I continue to distribute information to office-bearers, members and/or portfolio conveners as appropriate.

# Education Report - Anne Marie Boyd

#### Education

#### **Echline Primary School – Headteacher Recruitment**

The recruitment process for the new Headteacher at Echline Primary School is currently underway. The first stage of interviews is scheduled to take place on 16th September, followed by a second interview phase on 24th September.

#### Queensferry High School Council meeting

School Update Report – September 2025

#### 1. S1 Intake and Pupil Roll

Mr Downie, Headteacher, reported that the new S1 intake of 244 pupils has settled in well. The current school roll is just under 1,300.

#### 2. Performance and Attainment

Continued improvement across key performance indicators:

- Attendance is up
- Exclusions are down
- Exam results and attainment have improved
- Positive destination rates are also up

Mr Downie confirmed that a full breakdown of attainment will be provided once the school receives the Insight data from the Scottish Government, which includes comparisons against the school's Virtual Comparator.

Initial analysis shows strong progress in S4–S6 exam results, with notable increases compared to the 2024 Virtual Comparator and average performance from 2017–2019. The Enhanced Support Base (ESB) achieved qualifications across all subject areas and recorded its best results to date.

Mr Downie believes this progress demonstrates the positive impact of the new curriculum, and expects further improvement in future results.

#### 3. School Communications

The new school website is expected to launch around the September weekend.

Class Charts is back in use internally. It will go live for parents and carers by the September weekend once staff training is complete. This is a way for parents to see daily how their child has been getting on in classes by receiving positive or negative points.

All future school communications will go through Class Charts, with the exception of SMS messages which will continue as before.

A separate Class Charts platform for the Enhanced Support Base is being developed with class-based notifications.

#### 4. Parking on Station Road

Ongoing concerns about inconsiderate parking on Station Road, which poses a safety risk, especially for pupils crossing the road. Complaints have been received from the local residents' association.

Reminders to staff and sixth-year drivers and included messages in the school's weekly newsletter.

The issue has been raised with City of Edinburgh Council (CEC) by the school. While CD acknowledged that parking opposite zig-zag lines is unsafe, he noted the school has no authority to enforce restrictions. Parking by non-school drivers is also contributing to the issue.

#### 5. Facilities and School Extension

Summer works were completed successfully, including the installation of a new computing room. There has been no further communication from CEC regarding the proposed school extension. Mr Downie believes a business case for funding is currently being prepared.

#### **QHS** Awards night

I was pleased to attend the Senior School Awards Ceremony at Queensferry High School. It was a thoroughly enjoyable and inspiring evening, celebrating the achievements of young people across the curriculum.

Over 50 students were recognised for their hard work, commitment, and dedication to their studies and wider contributions to school life at QHS. It was a wonderful opportunity to acknowledge their accomplishments and the positive impact they have made within the school community.

#### Builyeon Road Development – Public Information and Feedback Session

I attended the City of Edinburgh Council (CEC) information and feedback session regarding the proposed Builyeon Road Primary School and active travel plans for the south side of Queensferry. The event took place at Echline Primary School and was well attended.

#### 1. Timescales for the New Primary School:

There was considerable interest in the timeline for the construction and opening of the new primary school. CEC representatives advised that the current target date for opening is December 2028. However, this is subject to a number of variables.

#### 2. School Catchment and Enrolment Concerns:

Several residents raised concerns about how the opening of the new school would affect families already living in the Builyeon Road development. Specifically, questions were asked about whether children attending other schools would be required to transfer to the new school once it becomes their catchment. CEC clarified that, in line with current policy, children already enrolled in a school will not be required to move due to catchment changes.

#### 3. Safer Routes to School and Road Infrastructure:

A major recurring issue raised by residents was the need for safer routes to school. Many expressed concerns about the rerouting of Builyeon Road and sought clarity on when this work would take place. Developers are currently working towards a completion date of December 2026 for the road diversion, although this is also dependent on a range of external factors.


Two temporary pedestrian crossings are planned to create safer crossing over Builyeon Road. However, no confirmed timeline was provided for when these crossings will be implemented.

#### 4. Cycle Lane on Scotstoun Avenue:

There was significant discussion around the proposed cycle lane on the north side of Scotstoun Avenue, with multiple residents raising concerns about potential safety risks.

# Young People Youth Clubs

All the local youth clubs have now restarted, four clubs running Tues-Friday between Queensferry & Kirkliston.



#### Lar Housing Trust Site Visit

Lar Housing Trust kindly invited myself, along with a group of young people, to visit their development site. I was joined by Keith, Graeme, and 14 young participants for the visit.



The group was given a guided tour of the site, during which the team explained in detail the potential dangers of accessing the area outside of working hours. This was a valuable opportunity as there has been lots of exploration of the site when the site is closed.

As part of the visit, each young person was invited to lay a brick in one of the site's walls. This brick will remain a permanent part of the development, offering the group a



meaningful and lasting connection to the project. This hands-on experience was both engaging and memorable for the young people involved.

They also particularly enjoyed exploring the old jail cells and being shown the areas of the site that are safe to enter.

#### The Binks Car Park

Following my approach to the City of Edinburgh Council (CEC) a new wooden barrier has been erected at the East End of the Binks car park to prevent vehicles being parked on the grassland in front of the flats.

#### The Pond and Surrounding Areas at the VAT Run

Following approaches from a member of the public and my fellow environmental committee members about the unmanaged and overgrown state of the pond and surrounds a site visit was undertaken by myself and fellow committee members.

The path leading to the pond is heavily overgrown by brambles and other bushes making it dangerous for the youngsters who attend the Echline Forrest Kindergarten to visit the pond to enjoy the wildlife, including frogs, which live there. The surrounding area of natural grassland is also heavy overgrown and the pond itself is full of grasses which are now chocking the pond itself.

I am arranging for a site visit meeting with the Manager of the CEC Parks and Green Spaces team in early October to ascertain what assistance they can provide to restore the area to a manageable state and thereafter agree some form of maintenance programme so that the youngsters and the general public can continue to enjoy this excellent wildlife environment which is formally designated as an area of particular environmental interest. This may involve establishing a new "Friends Group".

#### Jacobs Ladder

In conjunction with the QDCC Chair we are exploring further avenues to address the dilapidated state of the stairway.

Rosebery hall management committee held their quarterly meeting with hall users with good attendance. It was agreed that the MC would investigate provision of an induction hearing loop for the main hall.

The MC have managed to arrange a meeting with the Facilities Management and Andrew Field to discuss the difficult position that has been imposed by demands that any janitorial cover out of hours is to be requested from and paid for to CEC. This is a massive increase in outgoings that is not sustainable.

New Christmas lights have been purchased for the garden.

Petition: Nightly Anti-Social Behaviour and Vehicle Use in South Queensferry

Following submission of the public petition (which attracted over 500 signatures) demanding solutions from the City of Edinburgh Council to address the ongoing issues with anti-social car and bike racing in South Queensferry, the matter was addressed at a meeting of the City of Edinburgh Council Transport Committee on Thursday 11 September 2025.

The CEC Transport Committee unanimously agreed that:

- City of Edinburgh Council officials should be instructed to bring forward a report in two cycles setting out what practical options the Council could take to address effectively the issues raised in the petition without simply moving problems to other parts of the town.
- Further requests that the Interim Executive Director of Place (Gavin Barwell)
  - Writes to Police Scotland with details of the petition and seeks a detailed response on what action they are taking to address these issues of anti-social behaviour in South Queensferry
  - Includes the response from Police Scotland in the report back to the Committee
  - Makes the CEC Culture and Communities Committee aware of the petition and the approach to Police Scotland given its delegated powers around police oversight and scrutiny.

The CEC Transport Committee also believes that the petition provides further evidence of the need for City of Edinburgh Council to be given a broader range of powers to address racing vehicles, including the power to install and operate speed cameras, and requests that CEC council officers refer to this in their ongoing relevant discussions with Transport Scotland.

#### QDCC position

QDCC is maintaining a neutral position on the proposals contained within the petition. QDCC believes that there needs to be a solution for the whole town and any solutions should be directed at stopping the anti-social vehicle use entirely rather than just displacing it to another part of Queensferry and Dalmeny and District.

In due course, QDCC will work in partnership with the City of Edinburgh Council and will actively promote and participate in any future consultation exercise containing a series of options aimed at tackling anti-social behaviour vehicle use across the whole of Queensferry and District.

#### Ashburnham Gardens: Double yellow Lines

The correction to the provision of double yellow lines for Ashburnham Gardens was raised with all 4 Almond Ward Councillors and the response from the Convenor of the CEC Transport Committee indicates that

"The Road Safety Team are progressing the order to extend the double yellow lines. This has been delayed due to a request to extend the lines beyond the originally proposed extents, and additional details being requested on the drawings. The drawings have now been amended, and a request to proceed (under delegated authority in line with the Scheme of Delegation to officers) is expected to be completed by the end of August."

QDCC has subsequently been informed by Councillor Kevin Lang that the request to proceed has now been approved.

QDCC has written to all 4 Almond Ward Councillors urging them to:

- Continue to press for this matter to be addressed as a matter of urgency.
- Seek an interim solution from CEC through a Temporary Traffic Restriction Order or an Emergency Traffic Restriction Order to restrict parking on Ashburnham Gardens with immediate effect.

#### Queensferry High Street Improvement Works

The works on Queensferry High Street are due to commence on 6 October 2025 and will last around 15 months.

#### Meeting with Bear Scotland/Traffic Scotland

QDCC had a very positive meeting with Bear Scotland/Traffic Scotland to discuss a number of issues relating to the management of the trunk roads network and the Queensferry Crossing and the Forth Bridge. QDCC noted that BEAR Scotland are investigating ways to improve the flow of traffic using the Queensferry Crossing.

#### **Builyeon Road**

QDCC continues to raise road safety concerns in relation to Builyeon Road with Almond Ward Councillors and directly with City of Edinburgh Council officials. QDCC has stressed the critical need for installation of the two temporary crossings with immediate effect to ensure residents


from the new Bridgewater village estate can cross the road safely particularly within the context of the darker mornings and darker evenings.

The <u>Forth Bridges</u>, <u>Forever Edinburgh</u> and <u>CruiseForth</u> continue to promote the area citywide and beyond. There remains more opportunity to develop the VisitQueensferry brand, currently held by QDCC, for anyone wishing to take it onboard.

Visit Edinburgh/Forever Edinburgh continue to promote Queensferry along with other city neighbourhoods. Although listings are free for businesses to promote themselves, Queensferry does not have as comprehensive a listing of bsuinesses as it should. The 2025 cruise ship season is nearing end with 4 ships remaining for Queensferry, ending 9<sup>th</sup> Oct. This season has been very much lower in number of ships but 2026 is currently projected back up to 40 ships, subject to change.

The High St refurbishment is scheduled to commence 6<sup>th</sup> Oct, however it will focus on the Sealscraig to Hawes turning circle up until Christmas closedown, then commence at the The Loan end of the High St from early January, subject to change. The railings on the terraces will also be repaired during this phase. The High St will always remain open for business throughout and for the vast majority of time will have through access for vehicles, pinch point work being the only exception expected. There will be Itison voucher promotions, offering fully subsidised deals, please watch out for them and use it to experience our hard working businesses so we can all enjoy the completely refurbished High St in 2027.

#### Supporting local business

A great example of making the difference recently was a video plea put out by Jolene at <u>Oir Soap</u> last month. I would encourage watching the heartfelt video on <u>Oir Soap's Facebook page</u> about the difficult situation she was in and the follow up video after her clientele responded. It absolutely made the difference! We may all have ideas about what businesses we want to see here but if we do not support them with our spending, they evaporate.

There are many local events planned leading in to Christmas, with all the opportunity that brings. The full lisitings will be on the Christmas in Queensferry website shortly and updated regularly. Again supporting these events, markets, etc. helps sustain the local economy.

# Queensferry Business Group Report – Gill Fox

Our August meeting focused on the High Street refurbishment works. Presentations were made by Robert Armstrong, Project Manager for the High Street works, Rebecca Burnett re Forever Edinburgh and Spotlight on QF, and Chris Wilson re the Itison scheme to encourage shoppers to continue to come to QF.

This scheme will be supported financially by Edin Council in that the Council will make up the difference in value of the vouchers purchased (eg £10 voucher purchased for £5) so the QF business owners will not be subsidising the vouchers themselves.



However, there will be a cash flow delay between business owners providing the goods and receiving the Council payment. We are requesting that the Council amend their payment runs from fortnightly to weekly to shorten the cash flow implication.

Further detailed information will be provided at the next QBG meeting on 24<sup>th</sup>
September at 30 Knots, together with the proposed phases and timings of the High St works which are expected to start on 6 October.

#### Hawes Pier - Anti-Social Driving

Continuing our support for residents in Queensferry who have been having to live with the awful impact of anti-social driving. Residents brought a petition on the issue to the Council's Transport and Environment Committee (TEC). Kevin, as a member of the committee, additionally put in an amendment, accepted unanimously, which sought to ensure practical, helpful solutions are brought as options to committee when officers have considered what changes can be made.

#### Launch of Queensferry Directory

Lewis attended the launch of the Queensferry Directory, which gave a great opportunity to showcase the rich variety of community groups, businesses, and support available.

#### Community Connections - Scottish Housing Day

Louise attended the Scottish Housing Day Community Connections event organised by Lovell Housing. This provided the opportunity to emphasise not only the need for good quality affordable homes, but also highlight the need for improved social infrastructure throughout Queensferry.

#### Mobile Phones in Schools

The ongoing pilot scheme regarding mobile phone usage in Queensferry High School was used as part of the discussion at Education, Children, and Families Committee, where a ban on usage in Schools was approved, pending further consultation with young people, teachers, unions, and other relevant stakeholders. Additionally, an implementation plan and funding implications will need to be considered before the ban was brought into place.
